Ordinance No. 003-2007

“AN ORDINANCE RECLASSIFYING A PARCEL OF LAND UNDER TRANSFER CERTIFICATE OF TITLE NO. T-40872 FROM AGRICULTURAL TO NON-AGRICULTURAL”

SECTION 1. AUTHORITY TO RECLASSIFY Section 20 of Republic Act 7160 known as the Local Government code of 1991 empowers the Sangguniang Bayan to pass an ordinance reclassifying an agricultural lands to non-agricultural and to provide for the manner of their utilization.

SECTION 2. RECLASSIFICATION. A parcel of land with Transfer Certificate of Title No. T40872 is hereby reclassified from agricultural to non-agricultural;

SECTION 3. MANNER OF UTILIZATION. The said land shall be strictly utilized in accordance with all applicable laws, rules and regulations particularly the Municipal Zoning Ordinance;

SECTION 4. CONVERSION. This ordinance shall not be construed as a conversion order which shall be issued by the Department of Land Reform;

SECTION 5. This ordinance shall take effect upon approval.
