ORDINANCE No. 003-2010

AN ORDINANCE AMENDING SECTION 1 AND SECTION 5 OF MUNICIPAL ORDINANCE NO. 003-2004.

SECTION 1. Section 1 and Section 5 of Municipal Ordinance No. 003-2004 are hereby amended to read as follows:

Section 1. "Portions of Rizal Street and Burgos Street beginning the corner of Angara Street going east are hereby declared as **two way lane** and **no parking areas**."

Section 5. "The Baler PNP is hereby tasked to strictly enforce this ordinance and in support to its implementation the Municipal Engineering Office shall provide appropriate "No Parking" signage or billboard which shall be placed conspicuously within the subject portions of roads for public reference."

SECTION 2. Any ordinance found to be inconsistent with the provisions of this Ordinance is hereby repealed, amended and modified accordingly.

SECTION 3. This Ordinance shall take effect upon approval.
