ORDINANCE No. 004-2010

AN ORDINANCE PERMANENTLY CLOSING TO ALL TYPES OF VEHICLE PORTION OF T. MOLINA STREET (84 LINEAR METERS) AND SAN LUIS STREET (104 LINEAR METERS).

Whereas, Section 21 of the Local Government Code of 1991 provides that a local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction;

Whereas, it is further emphasized under the same section of the code that in case of permanent closure, such ordinance must be approved by at least two thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided;

Whereas, permanent closure of the portions T. Molina Street and San Luis Street is called for as the subject road facilities are inevitably affected by the expansion, improvement and refurbishing entailed in Baler Town Plaza development project;

Whereas, the general public recognizes the importance of the on-going improvement in Baler Town Plaza and thereby accepts the consequent closure of the subject road facilities;

Now therefore, on motion of Hon. Reynaldo E. Mapindan which was sanctioned by the rest of the SB members in session;

Be it Ordained by the Sangguniang Bayan of Baler, Aurora in a session duly assembled that:

SECTION 1. The following road/streets in Poblacion, Baler, Aurora are hereby permanently closed to all types of vehicle:

1. Portion of T. Molina Street (84 linear meters) being adjacent to Lots 2016, 223 and 224 Baler Cadastre;
2. Portion of San Luis Street (104 linear meters) being adjacent to lots 222, 223, 226 and 2016 Baler, Cadastre.

SECTION 2. The newly constructed road connecting Quezon Street and the rest of San Luis Street to the rest of T. Molina Street and Rizal Street shall be opened to all types of vehicle as an adequate substitute for the road facilities that are subject to closure.

SECTION 3. Repealing Clause: All Ordinances, rules and regulations, or part thereof, whose provisions are in conflict with, or contrary to the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 4. Effectivity. This Ordinance shall take effect upon approval.
