ORDINANCE NO. 005-2013

AN ORDINANCE EFFECTING CORRECTIONS IN APPROPRIATION ORDINANCE NO. 005 SERIES OF 2012 AS PER ADJUSTMENTS MADE BY THE LOCAL FINANCE COMMITTEE IN THE ANNUAL BUDGET OF BALER, AURORA FOR CY 2013.

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. The herein enumerated corrections and adjustments made on Appropriation Ordinance No. 005, series of 2013 of the Municipality of Baler, Aurora are hereby effected:

1. The total amount of CY 2013 budget indicated in the Title and in Section 1 of Appropriation Ordinance as Seventy Nine Million Three Hundred Five Thousand Three Hundred Sixty Five Pesos (P 79, 305, 365.00) was corrected/adjusted to Eighty One Million Three Hundred Five Thousand Three Hundred Sixty Five (P 81, 305,365.00).
2. In Section 2. Sources of Fund, the Total Available Resources for Appropriation was accordingly adjusted from P 79, 305,365.00 to P 81, 305,365.00.
