**ORDINANCE NO. 011-2012**

**AN ORDINANCE NAMING THE NEWLY CONSTRUCTED MUNICIPAL HEALTH CENTER LOCATED AT BRGY. SUKLAYIN, BALER, AURORA AS DR. ANDRES ARAGON ANGARA HEALTH CENTER.**

**Whereas**, Rule IV, Article 22 of the Implementing Rules and Regulations of the Local Government Code of 1991 provides that the sanggunian of component cities and municipalities may, in consultation with the National Historical Institute change the name of streets, roads, schools, health facilities or any other public place or building within its territorial jurisdiction;

**Whereas**, it is fitting and appropriate to honor the memory of the late Dr. Andres Aragon Angara, by naming the Municipal Health Center constructed at the lot he donated to the LGU in appreciation of his benevolence and liberality and in recognition of his selfless effort and dedication to promote health for the welfare and interest of his fellow Balerians;

**Whereas**, during his time, Dr. Andres Aragon Angara demonstrated unquestionable capability, integrity and spent the most precious and productive years of his life as a public servant not only in our country but also in international level;

**Whereas**, as a Doctor, he served as Public Health Officer, Director of Philippine Tuberculosis Center and Deputy Director of Asia Pacific Region-World Health Organization;

**Now therefore**, on motion of Hon. Karen G. Angara-Ularan duly seconded by Hon. Danilo M. Ong and Hon. Gina Z. Agapito;

*Be it ordained by the Sangguniang Bayan in a session duly assembled that:*

**Section I.** The newly constructed Municipal Health Center located at Brgy. Suklayin, Baler, Aurora is hereby named as **DR. ANDRES ARAGON ANGARA HEALTH CENTER.**

**Section II.** Repealing Clause. All ordinances, rules and regulations or parts thereof, in conflict with, or inconsistent with any provisions of this ordinance are hereby repealed and/or modified accordingly.

**Section III.** Effectivity. This ordinance shall take effect upon approval.
