ORDINANCE NO. 015-2012

AN ORDINANCE RECLASSIFYING A PARCEL OF LAND (LOT 2560 UNDER TCT NO. T-23696) IN SITIO PINAGPATIAN, BRGY. RESERVA, BALER, AURORA FROM AGRICULTURAL TO AGRO-TOURISM ZONE.

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

Section 2. RECLASSIFICATION. A parcel of land (Lot 2560 under TCT No. T-23696) located at Sitio Pinagpatian, Brgy. Reserva, Baler, Aurora is hereby reclassified from Agricultural to Agro-tourism Zone.

Section 3. MANNER OF UTILIZATION. The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Baler, Aurora and other applicable laws, rules and regulations.

Section 4. CONVERSION. This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval.
