ORDINANCE NO. 018-2013

AN ORDINANCE IMPOSING FEES ON BLOOD CHEMISTRY LABORATORY PROCEDURES-LIPID PROFILE TEST

WHEREAS, the Medical Laboratory has been established in the Municipal Health Office of Baler, Aurora;

Whereas, the Blood Chemistry Laboratory Procedures is indispensable in the management of the different diseases, particularly Cardiovascular Diseases, Diabetes and others;

Whereas, the needed laboratory supplies for this purpose are very expensive;

Whereas, the operation of the medical laboratory needs to be sustained and can be supported through the payments of clients who can afford to pay like Philhealth Members and Private Individuals;

NOW THEREFORE, be it enacted by the Sangguniang Bayan of Baler in session assembled, that;

Sec. 1. Title. This ordinance shall be known as "An ordinance imposing fees on Blood Chemistry Laboratory Procedure – Lipid Profile Test;

Sec. 2. Definition of Terms

- 1. Blood Chemistry is the chemical composition of blood.
- 2. Blood Chemistry Test is a test performed on the blood of a patient to determine its chemical composition prior to surgery or a procedure to examine the general health of a patient.
- 3. Lipid Profile Blood Test is a test performed to measure the cholesterol and its components including blood sugar level in the body.

Sec. 3. Lipid Profile Composed of:

- 1. Fasting Blood Sugar (FBS)
- 2. Total Cholesterol Triglyceride
- 3. High Density Lipoproteins (HDL)
- 4. Low Density Lipoproteins (LDL)
- 5. Triglyceride

Sec. 4. Imposition of Fees:

Lipid Profile Test 800.00

Sec.5. Exemption. The herein fees shall not be collected to indigent patient as certified by the Municipal Social Welfare and Development Officer (MSWDO), or proper authority;

Sec.6. The Municipal Medical Technologist performs only in the clinical laboratory if the patient has a corresponding request for Lipid Profile Test coming from the physician;

Sec. 7. Payment of Fees. The fees shall be paid directly to the Municipal Treasury Office or his authorized representative before the conduct of blood chemistry test by the Municipal Medical Technologist;

Sec. 8. Allocation of Funds. All fees collected shall be accrued to the General Fund of the Municipality of Baler and shall be allocated and appropriated to the procurement of the materials needed in Blood Chemistry Test subject to government budgeting, accounting and auditing rules and regulations;

Sec. 9. Separability Clause. All ordinance or parts thereof which are in conflict with any provision of this ordinance are hereby repealed or modified accordingly;

Sec. 10. Effectivity. This ordinance shall take effect upon approval.
