ORDINANCE NO. 020-2013

AN ORDINANCE PRESCRIBING FEES AND CHARGES FOR THE USE OF THE MUNICIPAL COMFORT ROOM LOCATED AT PUBLIC MARKET BUILDING AND CENTRAL TERMINAL OF BALER, AURORA.

Whereas, one of the specific provisions of the Local Government Code of 1991 states that the Local Government Units may fix the rates for the operation of public utilities owned, operated and maintained by them within its jurisdiction;

Whereas, the Municipality of Baler recognizing the increasing number of vendors, market goers, visitors and PUV passenger have provided the Baler Public Market and the Central Terminal with additional clean restroom to complete its physical capabilities and improve the service facilities for public welfare;

Whereas, the market management have considered this basic service facility as additional source of revenues of the Municipality of Baler while providing job opportunity for the maintenance of sanitary condition of the said facilities;

Whereas, with the enactment of this Ordinance by the Sangguniang Bayan, the prescribed fees and charges including the management, rules and regulations pertinent thereto shall be certainly expressed;

Now therefore, on motion of Hon. Meinrado C. Tropicales seconded by Hon. Reynaldo E. Mapindan;

Be it ordained by the Sangguniang Bayan of Baler in session assembled that:

Section 1. Imposition of Fee. There shall be collected fees for the use of the municipal owned comfort rooms located at the Public Market Compound of Baler, Aurora. The following fees shall be as follows:

Section 2. Times of Payment. The fee imposed herein shall be paid to the Municipal Treasurer or his authorized representative before using the comfort room.

Section 3. Administrative Provisions:

- a. Management and Maintenance- The comfort room shall be operated and maintained by the assigned Utility Worker who is under the supervision of the Market Administration Office.
- b. The assigned laborer shall maintain the sanitary condition of the comfort room at all times. They shall collect the necessary fees, entering in the drop box which shall be remitted daily to the assigned Revenue Collector Clerk who is in custody of the key and responsible in the issuance of the corresponding official receipt after counting the fees collected.
- c. The assigned Revenue Collection Clerk in the Market Administration Office shall maintain a separate ledger of incoming collections generated from the operation of Public Market Comfort Room.

Section 4. Penalty. Any violation of the provision of this ordinance shall be punished by a fine not less than One Thousand Pesos (P 1,000.00) but not more than Two Thousand Five Hundred Pesos (P 2,500) or imprisonment of not less than one (1) month, but not more than six (6) months or both such fine and imprisonment at the discretion of the court.

Section 5. Effectivity. This ordinance shall take effect upon approval.
