ORDINANCE NO. 021-2013

AN ORDINANCE RECLASSIFYING PARCELS OF LAND (LOT 2446-D-9-A, 2446-D-9-B, 2446-D-9-C, 2446-D-9-D, 2446-D-9-E, 2446-D-9-F, 2446-D-9-G, 2446-D-9-H, 2446-D-9-I, 2446-D-9-J OF THE SUBDIVISION PLAN, PSD-436388) LOCATED AT BRGY. RESERVA, BALER, AURORA FROM AGRICULTURAL TO RESIDENTIAL ZONE.

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

Section 2. RECLASSIFICATION. The Parcels of Land (Lot 2446-D-9-A, 2446-D-9-B, 2446-D-9-C, 2446-D-9-D, 2446-D-9-E, 2446-D-9-F, 2446-D-9-G, 2446-D-9-H, 2446-D-9-I, 2446-D-9-J of the Subdivision Plan, PSD-436388) located at Brgy. Reserva, Baler, Aurora are hereby reclassified from Agricultural to Residential Zone.

Section 3. MANNER OF UTILIZATION. The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Baler, Aurora and other applicable laws, rules and regulations.

Section 4. CONVERSION. This ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval.
