**ORDINANCE NO. 024 -2013**

**AN ORDINANCE FOR THE IMPLEMENTATION OF THE TRICYCLE FARE FOR TOURIST SERVICE IN THE MUNICIPALITY OF BALER, AURORA**

**Whereas**, Baler is one of the places known as tourist destination in the Philippines;

**Whereas**, after comprehensive study regarding the needed transport fare introduced by the tricycle operators/drivers, the findings of the august body are reasonable;

**Whereas**, the LGU Baler aims to improve the business relationship of transport sector and its clients;

**Whereas**, Article 100 (3) (vi) of the Implementing Rules and Regulations of RA 7160, empowers the municipality to regulate the operation of tricycles and grant franchises for the operation thereof within its territorial jurisdiction;

**Now therefore**, on motion of Hon. Ramir D. Duaso, duly seconded by Hon. Danilo M. Ong;

**Be it ordained**, by the Sangguniang Bayan in a session assembled that:

**Section 1.** The Tricycle Fare for Tourist Service in the Municipality of Baler, Aurora shall be as follows;

- P 500.00 – within the Municipality of Baler (all tourist spots in Baler, between 8:00AM-5:00PM).
- P 800.00 - within the Municipality of Baler, Mother Falls and Balete Tree.
- P 800.00 - within the Municipality of Baler, Ampere and Mother Falls.
- P 800.00 - within the Municipality of Baler, Balete Tree and Ampere.

e) P 1,000.00 - within the Municipality of Baler, Mother Falls, Balete Tree and Ampere.

**Section 2. PENALTIES.** For violation of its ordinance, the perpetrators shall be penalized to pay fine as follows:

- a) 1<sup>st</sup> Offense: A fine of Five Hundred Pesos (P 500.00).
- b) 2<sup>nd</sup> Offense: A fine of One Thousand Pesos (P 1,000.00).
- c) 3<sup>rd</sup> Offense: A fine of Two Thousand Pesos (P 2,000.00) and cancellation of registration, MTOP and license to operate as Tourist Service Vehicle.

**Section 3. IMPLEMENTING OFFICE.** The Municipal Tourism Office, Philippine National Police – Baler and Municipal Tourism Council Representative shall be the lead agencies in the implementation of this ordinance;

**Section 4. REPEALING CLAUSE.** Any ordinance or parts thereof which are contrary and inconsistent with the provisions of this ordinance are hereby repealed, amended and modified accordingly;

**Section 5. EFFECTIVITY.** This ordinance shall take effect after ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the Municipal Building of Baler, Aurora and in at least two (2) conspicuous places in the municipality.
