**INVITATION TO BID FOR THE
CONSTRUCTION OF CONCRETE CANAL LINING, Gab-Gab Tabon,
Barangay Buhangin,
BALER, AURORA**

1. The **Municipal Government of Baler**, through its BUB & LGSF Fund, intends to apply the sum of **Three Million Pesos (PhP 3,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the **Construction of Concrete Canal Lining, Gab-Gab Tabon, Barangay Buhangin, Baler, Aurora**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Municipal Government of Baler** now invites bids for the **Construction of Concrete Canal Lining, Gab-Gab Tabon, Barangay Buhangin, Baler, Aurora**. Contract Duration is **One Hundred Twenty (120) Calendar Days upon Contract Signing**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from **BAC Secretariat, Office of the MPDC, Municipal Government of Baler** and inspect the Bidding Documents at the address given below during office hours.

Interested bidders shall pay an amount of **Five hundred Pesos (PhP 500.00) registration fee** to be included in the list of registered suppliers of the municipal government. A complete set of Bidding Documents may be purchased by interested Bidders on **July 28, 2016** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (PhP 5,000.00)** only.

5. The **Municipal Government of Baler** will hold a Pre-Bid Conference on **August 11, 2016, 9:00 A.M.** at **2nd Floor Conference Room, Executive Building, Baler, Aurora**, which shall be open to all interested parties.

6. Bids must be delivered to the address below on or before **9:00 A.M of August 23, 2016**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **9:00 A.M of August 23, 2016 at 2nd Floor Conference Room, Executive Building, Baler, Aurora**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **Municipal Government of Baler** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
